Reminder: Time is Running Out For Your Company to Benefit From Class Action Suit Against Forwarders



As a reminder, the deadline of **November 22, 2013**, for filing claims in the ongoing class action case, *Precision Associates, Inc. v. Panalpina World Transport*, No. 08-cv-00042 (E.D.N.Y.), is rapidly approaching. If in the last 10 years, your company utilized the services of one or more of the freight forwarders in the attached list, you may be entitled to a potentially significant cash settlement.

The lawsuit alleges that freight forwarding companies conspired to price-fix the cost of freight forwarding services from January 2001 through September 2012. This alleged conspiracy occurred throughout the world and included shipping routed between the United States and China, Hong Kong, Japan, Taiwan, and the United Kingdom.

Certain companies have already provisionally received significant settlements (\$100,000.00+). Accordingly, if you have purchased freight forwarding services from any of the listed companies, you should consider filing a claim.
